General Rates Information:

The budget has been formulated with an increase of 3% on rate in the dollar for GRV (within town site) and 3% on rate revenue for UV properties. The UV valuations carried out by Landgate substantially increased the value of these properties (on average by 20.31%) which has had a bearing on the setting of rates. This has led to the rate increase being formulated off total revenue which will reduce the rate in the dollar.

Rising input costs required to maintain our main source of expenditure, being roads, and the increased pressure placed on the shires vast network of gravel roads (2150km) by an increase in the size of machinery and increased machinery movements have a big impact on the Shires ability to maintain the roads to a suitable standard that is demanded by the main users. Rate increases assist in provision of service delivery that meets reasonable community needs. It also ensures that critical infrastructure asset renewal is somewhat funded over the time frame of the Long Term Financial Plan.

The following general and minimum rates on Gross Rental and Unimproved Values has been imposed:

Specified area Rates – Sewerage:

The 2025/26 budget has been prepared with a 3% increase in specified area rate revenue for the Lake Grace Sewerage Scheme.

Borrowings:

The outstanding loan principal at 1 July 2025 is \$1,617,248. The principal repayments for 2025/26 amount to \$202,299 and interest payable of \$69,731 leaving a balance of \$1,414,949 at 30 June 2026.

Infrastructure — Parks, Gardens & Recreation Facilities:

A total of \$540,584 has been allocated for capital parks and garden works which include:

- Lake Grace Sporting Complex Entry
- Lake King Park Upgrade
- Jam Patch Upgrades including New Walkway
- Newdegate Bowling Club Reconstruction & Resurfacing Project

Property, Plant and Equipment:

An amount of \$1,232,663 has been allocated to Shire Building refurbishment and upgrades including Shire houses, Lake Grace Community Bus Shed, Lake Grace/Newdegate/Varley Hall Refurbishment, Lakes Village Hall, Lake King Sports Pavilion, Lake Grace Sporting Precinct, Newdegate Recreation Centre, Lot 352 Stubbs St (Pink Building), AIM Building, Lake Grace RSL Hall, Lake Grace/Newdegate Depot Upgrades, Lake Grace Visitor Centre and Hainsworth Museum Shed.

The Shire is currently in the process of applying for grant funding to release more residential land. An amount of \$300,000 has been included to purchase Industrial Land in Lake Grace which will in turn be subdivided at a later date.

2025-2026 Due Dates

Pursuant to section 6.45 of the Local Government Act 1995 and regulation 64(2) of the Local Government (Financial Management) Regulations 1996, Council nominated the following due dates for payment in full or by instalments:

The cost associated with instalment options:

Instalment Interest—5.5% per annum

Penalty Interest Charges on Overdue Rates:

Under the Local Government Act 1995 interest is charged on overdue amounts. Council has set the charge at 7% per annum which will be applied to all amounts outstanding after 35 days from the issue date of the rate notice. Penalty interest accrues daily until all overdue rates and charges are paid in full. Eligible pensioners are exempt from interest charges.

Refuse Charges:

Pursuant to section 67 of the Waste Avoidance and Resources Recovery Act 2007, Council adopted the following charges for the removal and deposit of domestic and commercial waste.

Weekly Kerbside Collection:

& Varley (per service) \$156.50 (GST Free)

Eligible Pensioner (per service) \$89.00 (GST Free)

Eligibility is defined in the Rates and Charges (Rebates and Deferments) Act 1992.

Recycling Kerbside Collection:

Lake Grace & Newdegate Fortnightly
Collection (per service) \$161.00 (GST Free)

One of many services your Local Government provides is the Lake Grace Sewerage Scheme:

The Shire will provide a customer with the following on request and at no charge:

Commercial Waste:

Pursuant to section 67 of the Waste Avoidance and Resources Recovery Act 2007 and section 6.16 of the Local Government Act 1995 the following charges for the deposit of commercial waste apply:

Financial Hardship Policy for Water Services:

The Shire will assist a resident who cannot pay the wastewater service portion of a rate notice because of financial hardship in accordance with the Shire's "Financial Hardship Policy for Water Services".

Approval will be considered where the resident can show that the payment of the wastewater service portion of their rate notice will affect the resident's basic living needs.

Our policy applies only to the wastewater service portion of the rate notice.
