#### **Summary**

For Council to consider the Audit & Risk Committee's recommendations on the Chief Executive Officer's review on the appropriateness and effectiveness of Shire's systems and procedures in relation to risk management, internal control and legislative compliance in accordance with r.5, Local Government (Financial Management) Regulation 1996 and r.17 Local Government (Audit) Regulation 1996.

#### Background

The Local Government (Financial Management) Regulation 1996 and Local Government (Audit) Regulation 1996, state the CEO functions and responsibilities reviewing the appropriateness and effectiveness of the local government's systems regarding risk management, internal control and legislative compliance.

Furthermore Regulation 17 requires a local government's Chief Executive Officer to review, not less than once every three (3) financial years, the appropriateness and effectiveness of the local government's systems and procedures regarding risk management, internal control and legislative compliance and provide a report of that review to the local governments Audit Committee for their consideration.

#### Comment

The last Regulation 17 Audit review for the Shire of Lake Grace was undertaken by the Paxon Group and accepted by Council on 28 July 2021, which was also included the Shire's annual Compliance Audit Return for 2021. Regulation 5 Financial Management Review was last conducted in Feb-Mar 2023 and finalised in April 2023 by the Paxon Group.

External consultants Paxon Group were again engaged to assist with the audit review of Regulation 17 and incorporates the review for Regulation 5 as well for the purpose aligning both reviews done at the same time.

The review is to assist the CEO in reporting to the Audit and Risk Committee on the appropriateness and effectiveness of the Shire's systems and procedures in relation to risk management, internal control, and legislative compliance.

In addition, the review focussed on the implementation of audit recommendations from the previous Regulation 5 review.

#### Legislative Compliance:

The Shire identifies applicable legislation and keeps track of amendments to such legislation.

Except for the Waste and Fleet business unit's employees, Shire employees are educated as to Shire's and their own legislative responsibilities.

- (1) The CEO is to review the appropriateness and effectiveness of a local government's systems and procedures in relation to
  - (a) risk management; and
  - (b) internal control; and
  - (c) legislative compliance.
- (2) The review may relate to any or all of the matters referred to in sub regulation (1)(a), (b) and (c), but each of those matters is to be the subject of a review at least once every 3 calendar years.
- (3) The CEO is to report to the audit committee the results of that review.

#### Summary

This report seeks the Council's endorsement of the Shire of Lake Grace's submission in response to WALGA's June 2025 Discussion Paper on Communications Agreements. The submission provides feedback on the Draft Local Government Regulations Amendment Regulations 2025 and the Draft Local Government (Default Communications Agreement) Order 2025.

#### Background

The Minister for Local Government's reform process includes the introduction of regulated Communications Agreements between Councils and Chief Executive Officers (CEOs). These agreements aim to clarify communication channels, roles, and responsibilities between Elected Members and Administration.

WALGA has distributed a Discussion Paper to Local Governments to seek feedback on the draft regulations and order before submission to the Department of Local Government, Sport and Cultural Industries (DLGSC). Local Governments are encouraged to submit their endorsed responses by 28 July 2025.

#### Comment

The Shire of Lake Grace has reviewed the Discussion Paper and provided comprehensive responses to each key section, expressing views on matters such as:

- The prescriptive nature of the Draft Regulations and Order
- Commencement timelines
- Definitions and processes for requests for information and administrative matters
- Nomination of employees by the CEO
- Dispute resolution mechanisms
- Alignment with the Local Government Act 1995 and the Model Code of Conduct

The Shire's response emphasises the need for flexibility, local context, and preservation of clear governance-operational boundaries. The submission also recommends simplifying certain

provisions to reduce administrative burden and improve practical implementation for smaller Local Governments.

#### **Legal Implications**

The Communications Agreements are proposed to be mandated through amendments to the *Local Government Act 1995* and the associated regulations. Once gazetted, the default agreement will apply to all Local Governments post-election (from 19 October 2025), unless an alternative compliant agreement is in place.

#### **Policy Implications**

The endorsed response may inform the Shire's future policy development or internal protocols for managing Councillor communication with staff, in line with upcoming legislative reforms.

#### <u>Summary</u>

For Council to receive and endorse the statutory review of the Shire of Lake Grace Activities on Thoroughfares and Trading in Public Places Local Law.

#### **Background**

At the ordinary meeting held 28<sup>th</sup> August 2024, the Council noted and resolved to undertake an amendment review to the Activities on Thoroughfares and Trading in Public Places Local Law in accordance with the provisions of section 3.16 of the *Local Government Act 1995*.

Statewide and local public notice of the local laws review process was provided as required under the Act via an advertisement in *The West Australian* newspaper on Saturday 23<sup>rd</sup> September 2023, the Shire website and Facebook account, and flyers on local noticeboards throughout the district. The period for submissions from any interested parties closed on Monday 6<sup>th</sup> November 2023; there were no such submissions, nor any other form of feedback received by the closing date.

#### Comment

It was advised on the 28<sup>th of</sup> August 2024 meeting that the Council undertakes a review and amends the <u>Activities on Thoroughfares and Trading in Thoroughfares and Public Places Local Law,</u> in particular Part 5 relating to Roadside Conservation. Part 5.1 'Interpretation' references definitions of "protected flora" and "rare flora" in the now-repealed Wildlife Conservation Act 1950 which has since been replaced by the *Biodiversity Conservation Act 2016*. Part 5.4 'Construction works on flora roads' also refers to the Roadside Conservation Committee of WA Handbook of Environmental Practice for Road Construction and Road Maintenance Works (April 2005) which was revised and updated in May of 2010.

#### Statutory Environment / Legal Implications

#### Local Government Act 1995

- 3.16 Periodic review of local laws
- (1) Within a period of 8 years from the day when a local law commenced or a report of a review of the local law was accepted under this section, as the case requires, a local government is to carry out a review of the local law to determine whether or not it considers that it

should be repealed or amended.

- (2) The local government is to give Statewide public notice stating that
  - (a) the local government proposes to review the local law; and
  - (b) a copy of the local law may be inspected or obtained at any place specified in the notice; and
  - (c) submissions about the local law may be made to the local government before a day to be specified in the notice, being a day that is not less than 6 weeks after the notice is given.
- (2a) A notice under subsection (2) is also to be published and exhibited as if it were a local public notice.
- (3) After the last day for submissions, the local government is to consider any submissions made and cause a report of the review to be prepared and submitted to its council.
- (4) When council has considered the report, the local government may determine\* whether or not it considers that the local law should be repealed or amended.

#### Summary

For Council to grant temporary approval for the development of emergency grain storage on portion of Lot 1529 on Deposited Plan 204221 Varley Road, Lake King immediately to the north of Cooperative Bulk Handling Limited's existing grain handling and storage facility consisting of two 190m x 35m steel framed open bulkheads situated on cleared farmland.

#### Background

In FY21/22 the Shire approved a similar request from CBH albeit for a paddock across the road. This request was conditioned that the temporary works approval was only valid if consultation was undertaken and approval also obtained from MRWA. CBH never acted on this approval.

CBH is currently in the process of preparing for the event of a peak harvest in FY25/26 and preparing for larger crops sooner than originally contemplated. To address this increased demand, it is proposed to utilise open bulkhead storage that has a lower specification than permanent bulkhead storage such as a gravel or dirt basecourse serviced with Drive Over Grids (DOGs).

A concept plan is attached showing the preferred location on farmland across the road from CBH's existing site.

#### Comment

The proposal from CBH was discussed with the Shire Town Planner Joe Douglas who has advised that the same terms and conditions previously recommended would still apply.

His previous advice from the September 2021 proposal was as follows;

"My recent discussions with DPLH have confirmed development by CBH of this type is best defined as 'Industry-Rural' which is a use not listed in Local Planning Scheme No.4. This means any development application received must be classified as 'complex' and advertised for public comment for a minimum required period of 28 days. As such, I can't see Council being in a position to consider and determine any development application received until October. Given the 2021/22 harvest season will most likely commence at the beginning of November I can't see CBH having this proposed development completed in time.

The only other possible option that you and Council may wish to consider is allowing CBH to proceed with the project without the development approval typically required provided they formalise the development at some point over the next twelve (12) month period. Under the terms of clause 61 of the Planning and Development (Local Planning Schemes) Regulations 2015 a local government may grant approval for temporary works and/or uses that are in existence for less than 48 hours, or a longer period agreed by the local government, in any 12-month period. This means there is scope for Council to allow CBH to proceed almost immediately and to formalise everything by way of a DA over the course of the next year. We did this in the Shire of Corrigin recently for the same type of development by CBH in the Corrigin townsite and that Council was very supportive. The Lake Grace Shire Council's willingness to adopt a similar approach in Lake King and Lake Grace for the sake of expediency is the \$64,000 question and is something you may wish to flag with Councillors ASAP so we can advise CBH accordingly.

CBH are in the process of lodging a 'new or amended access application' with MRWA for access to the new temporary storage from the existing access and for a time limited period. To date these discussions appear positive as the long-term solution is the purchase of MRWA land between the existing facility and the landholding the subject of this application which they are currently negotiating purchase with MRWA. CBH would therefore welcome similar conditions to the ones

previously issued and will issue the Shire with the MRWA access endorsement once received and prior to construction.

Given the very favourable harvest being predicted it is recommended that Council allow CBH to proceed with the project without the development approval typically required provided they formalise the development within the next twelve (12) month period.
