





8.4.2 (Item 7.2.1) Enhanced and Alternative Education Opportunities for Regional WA

BACKGROUND:

At the April Zone meeting, it was resolved that;

That the Central Country Zone:

- 1. Supports the call to action to reduce regional disadvantage in educational opportunities, with a focus on:
 - I. The allocation of permanency to teachers who are then not based in the school for which they have been granted permanency.
 - II. Requesting clarity about how schools are classified as "hard to staff"
 - a. What is being done to adequately staff and house teachers in regional WA.
- 2. Agrees to write to the Minister for Education requesting action; and
- 3. Requests WALGA to advocate to State Government on this matter.

The Executive Officer wrote to the Minister for Education and received a reply.

Comment:

The Executive Officer shared the Departments draft Regional Education Strategy prior to the meeting. This strategy was referenced during the meeting.

The Executive Committee recommended that a Zone submission should be prepared based on issues identified by the Zone at the August meeting.

That the Zone prepare a submission to the Draft Regional Education Strategy on the following issues:

• 60% of students in remote schools are not meeting NAPLAN proficiency benchmarks

- Lack of quality education is a major impediment to attracting and retaining skilled and unskilled labour in Western Australia's regions and accordingly a major impediment to economic growth and standards of living
- Lack of quality education in regional areas is a significant source of social stratification and exacerbates socio-economic inequality in regional areas
- The interests of schools as organisations and educators are not necessarily aligned with the best interests of students or regional communities
- Housing and staff issues
- Subsidising teaching degrees to encourage teachers to move to regional and rural areas.
- Overall costs of operating schools (Operating costs of school ovals subsidy needed) and (Funding for regional students for excursions).

At the June meeting, it was resolved:

That the Central Country Zone representing the Local Governments of Beverley; Brookton; Corrigin; Cuballing; Dumbleyung; Kulin; Lake Grace; Narrogin; Pingelly; Quairading; Wagin; Wandering; West Arthur; Wickepin; Williams resolves that:

- The Governance process by which the decision was made does not accord with good public policy principles. It does not fit the science, did not involve genuine engagement and appears to be based on political ideology which does not serve the regional, state or national interest.
- the Federal Government withdraws its current Export Control Amendment (Ending Live Sheep Exports by Sea) Bill 2024.
- express disappointment in the Federal Government and lack of acknowledgement and understanding of the impact on regional communities that decisions like this have.
- a letter to the Prime Minister be written detailing the above be signed by the President of the Central Country Zone on behalf of members.

9 ZONE BUSINESS

9.1.1 <u>Clearing Permit Issues and Challenges for Local Governments in Wheatbelt Region</u> Shire of Corrigin

BACKGROUND

The Shire of Corrigin present a discussion paper on Clearing Permit Issues and Challenges for Local Governments in Wheatbelt regions.

At the Shire of Corrigins most recent Ordinary Council Meeting, the Shire resolved:

That Council submit the following draft proposals to the next WALGA Central Country Zone and work with local governments to advocate for:

- 1. Amendment of the Environmental Protection Act 1986 and associated Regulations to exempt the extension, widening or realignment of an existing regional or local distributor road from requiring a clearing permit for permitted purpose of road safety. Major projects involving clearing outside the agreed clear zone such as major road corridor realignment, additional lanes or minor local road may still require clearing permit.
- 2. The development of an approved policy as described in the Environmental Protection Act 1986 Schedule 6 2 (v) permitting clearing of all hazards in the clear zone or within 8 metres of the centre line on regional and local distributor roads based on the road safety principles and Austroads Guide to Road Design.
- 3. The Department Water and Environmental Regulation (DWER) to implement changes to the standard clearing permit conditions to remove unnecessary red tape and compliance cost burden on local government based on a perceived risk by a third party rather than evidence of actual non compliance of revegetation by the permit holder.
- 4. Simplification of the clearing permit process to clarifying ambiguous terms and provide clearer guidelines to enhance understanding and compliance with conditions while maintaining high environmental standards.

5. A whole landscape approach to maintaining habitat for black cockatoos including management of crown reserves, bush fire prevention and salinity control.

9.1.2 (Item 8.6.3)South West Native Title Settlement – Noongar Land Estate Shire of Dumbleyung

BACKGROUND

The South West Native Title Settlement is a landmark native title agreement reached between the State Government and the six Noongar Agreement Groups. The six requisite Indigenous Land Use Agreements (ILUA's) were conclusively registered leading to the Settlement commencing on 25 February 2021. The Settlement recognises the Agreement Groups as the Traditional Owners of the south west of Western Australia, while resolving native title in exchange for a negotiated package of benefits.

A key negotiated benefit is the delivery of a 320,000 hectare Noongar Land Estate, in accordance with the Noongar Land Base Strategy. The Noongar Land Estate will contain up to 300,000 hectares of land transferred in reserve or leasehold, and up to 20,000 hectares of land transferred in freehold. The Landholding Body for all land transferred is the Noongar Boodja Land Sub Pty Ltd, which will hold and manage the land in the Noongar Land Estate in consultation with the soon to be established Noongar Regional Corporations. All land will be used and managed in line with Noongar cultural, social and economic aspirations for the benefit of future generations.

The Department of Planning Lands & Heritage (DPLH) is the lead State Government agency tasked with the responsibility of identifying, negotiating and facilitating the necessary arrangements to transfer existing parcels of State owned land across to the Landholding Body. Up until now, DPLH has only engaged LGAs when specific land parcels are prioritised by the Noongar People for transfer consideration. Part of this engagement effort invites a LGA to consider each land site being proposed for transfer and provide feedback on the LGAs position usually within a relatively tight timeframe i.e. 42 calendar days. These deadlines don't allow for broader key stakeholder and community engagement to properly occur.

A letter was sent to DPLH on 7th June 2024 seeking an update on the status of unallocated Crown land and unmanaged reserves within the Shire of Dumbleyung, which are under consideration for possible inclusion in the Noongar Land Estate. DPLH responded confirming that 183 land parcels, totalling 1,456 hectares are currently under consideration within the Shire's boundaries. This would appear to cover all current State Government controlled land holdings. DPLH also confirmed a process that as land progresses through the phases of a Noongar Land Base Strategy, it may be prioritised or discontinued, depending on the aspirations of the Noongar People. DPLH advise that the 101 LGAs within the boundaries of the Settlement are acknowledged as important stakeholders

in the delivery of this commitment and will be consulted on an ongoing basis in accordance with section 14 of the Land Administration Act 1997.

Comment

DPLH has initiated formal contact with the Shire of Dumbleyung (by email) on each occasion a land holding is being earmarked for transfer. Each proposal is considered on its own merits usually taking into account current or neighbouring uses, existing access corridors & routes, strategic alignment and/or importance, potential or previous land use conflicts, applicable planning requirements, etc. Due to limited timeframes for provision of a response, there is no opportunity for a broader proper community engagement process to be initiated.

DPLH confirm that there are currently 6 land parcels (511.22 hectares) that have already been offered by the State Government for transfer in the Shire of Dumbleyung. This is despite some of these parcels having already been formally considered and rejected by the Dumbleyung Shire Council for various reasons. There are a number of Shire of Dumbleyung concerns in relation to the current State Government land consideration and transfer approach:-

- 1. Limited timeframe capacity for Local Government to properly engage the community.
- 2. No DPLH feedback given once a Local Government considers and responds to each land transfer request.
- 3. Clarification required on how Local Government rating will be able to be facilitated once each land is transferred, particularly land set aside for economic use.
- 4. Increased transparency on the overall engagement requirements (under the Land Administration Act 1997); noting it currently feels like a one sided 'tick the box' exercise.

Comment:

In the absence of the Shire of Dumbleyung at the august meeting, this item was deferred to the November meeting of the Zone.

9.1.3 Audit Fees

BACKGROUND:

At the August Executive Committee Meeting, President Cr Phil Blight raised the issue of Audit Fees. The below is an extracted item from the September State Council Agenda.

The WALGA State Council considered an Emerging Issue item at the July State Council meeting on Office of the Auditor General increased audit fees.

In June, many Local Governments were advised that the costs of the 2023-24 audit (which is well underway) would increase substantially. The correspondence advised that the average fee increase across the sector would be 21%. In many Local Governments, especially, smaller local governments the fee increase is much higher.

The WALGA State Council resolved as follows:

That State Council:

1. Objects to the Office of the Auditor General's audit fees increases for the 2023-24 audits of accounts and annual financial report of Local Governments; and

2. Requests the Legislative Council's Standing Committee on Estimates and Financial Operations to conduct an Inquiry into the OAG's performance of audits and increased audit fees to Local Governments.

A copy of the agenda item was attached.

Correspondence has been sent to the Legislative Council's Standing Committee on Estimates and Financial Operations and WALGA is waiting on a response.

- a. Disruption to schools arising from policies relating to permanency for teachers;
- b. Requesting clarity about how schools are classified as "hard to staff; and
- c. Improving housing for teachers in regional WA:
- 2. Agrees to write to the Minister for Education requesting action; and

WALGA understands that the Great Southern Zone received a response to their letter to the Minister of Education on this issue on 24 April 2024. The letter references a number of initiatives including a \$7.1 million funding boost for the School of Isolated and Distance Education, a proposed expansion of VET certificates in the coming years, Education and Training Participation Plans, the support provided by the School of Special Educational Needs: Behaviour and Engagement located in Albany, the recently announced federally funded two new Regional University Study Hubs, further financial investment in the attraction and retention payments/packages, and a developing Regional Education Strategy.

WALGA is also aware that the Great Southern Zone has raised these issues directly with Department of Education representatives at recent Zone meetings.

WALGA notes that 2024-25 State Budget included an additional \$10 million for the School of Isolated and Distance Education.

WALGA is continuing to advocate broadly on issues that intersect with regional education such as Government Regional Officer Housing (GROH). WALGA has written to the Department of Communities Deputy Director General, Housing and Assets on this matter. Department of Communities officials will present on the GROH program at the July State Council Strategic Forum.

On the 22 July, the Department of Education released a draft Regional Education Strategy. The Strategy aims to provide a framework to guide more effective delivery of regional education, focusing on improved educational and wellbeing opportunities across four pillars:

- Pillar 1: Build the capability of our regional workforce
- Pillar 2: Expand curriculum delivery
- Pillar 3: Strengthen support for student wellbeing
- Pillar 4: Develop partnerships to create opportunity

Country zones and Local Governments are strongly encouraged to provide feedback on the strategy, particularly given the relevance of the Strategy to matters raised by the Great Southern Zone with support from other country zones.

8.1 LOCAL GOVERNMENT ELECTIONS ANALYSIS 2015-2023

WALGA RECOMMENDATION

That WALGA advocate to the State Government:

- 1. For an independent Local Government election audit, focusing on the Western Australia Electoral Commission's (WAEC) service delivery and cost allocation methods and costing applications used, to confirm that marginal cost recovery principles are applied and that the costing program is being effectively managed.
- 2. For the requirement for the WAEC to develop and implement Service Level Agreements with Local Governments, similar to those agreements currently used in New South Wales and Victorian Local Government elections and that includes:
 - a. transparency of costing methodology,
 - b. direct engagement with Local Governments pre and post elections, and
 - c. the roles and responsibilities of the WAEC and Local Governments in the conduct of elections.

- 3. For the introduction of a provision for private service providers to enter the market for the conduct of Local Government elections.
- 4. For a mandated WAEC Report to Parliament specific to Local Government elections post each election cycle, outlining costs, results, voter turnout and matters for improvement both in the conduct of elections and the legislation, if relevant.

EXECUTIVE SUMMARY

- This report presents the findings of a comprehensive review and analysis of five election cycles up to and including the 2023 Local Government election against the backdrop of legislative reforms to the Local Government electoral process in Western Australia.
- With a focus on postal elections conducted exclusively by the Western Australian Electoral Commission (WAEC), the analysis has found evidence of the rising cost of conducting Local Government elections in Western Australia.
- Elected Member feedback, costs vs service comparisons and engagement by the sector with WALGA's governance services over the 2023 Local Government election period, are the basis for the recommendations as outlined above.
- The Governance Policy Team considered this item at its meeting of 7 August and endorsed the position for consideration by State Council

It is essential that the energy transition currently underway delivers economic opportunities, ensures reliable and affordable electricity, and the greatest possible benefits for the community.

WALGA calls on the State Government to develop a comprehensive framework to manage the impact of the energy transition that includes local engagement and the realisation of **Local** community benefits from energy transition projects as a priority.

EXECUTIVE SUMMARY

- Western Australia's energy industry is transforming to achieve the goal of net zero emissions by 2050.
- In Western Australia there is no framework that provides a consistent approach to how proponents of major energy projects consult with local communities and how they can share in the benefits.
- WALGA will advocate for the State Government to develop a framework to guide consultation and benefit sharing with local communities during the energy transition.
- A joint meeting of the Environment Policy Team and Infrastructure Policy Team held on 10 July endorsed the position for consideration by State Council.
- This draft advocacy position should be considered in conjunction with the accompanying draft WALGA advocacy positions Renewable Energy Facilities (Item 8.3) and Priority Agriculture (Item 8.4).

8.3 RENEWABLE ENERGY FACILITIES ADVOCACY POSITION

WALGA RECOMMENDATION

That State Council endorse a new Renewable Energy Facilities Advocacy Position as follows:

The growth in the number, size, and complexity of renewable energy facilities across Western Australia is expected to continue as energy generation and other traditional industries de-carbonise their facilities and operations. The renewable energy state planning framework requires changes to ensure it is fit for purpose to guide the ongoing development of this sector.

WALGA calls on the State Government to:

- 1. Adopt a new State Planning Policy for renewable energy facilities, to replace the existing Position Statement: Renewable energy facilities, that:
 - a. Facilitates the orderly development of renewable energy facilities across Western Australia;
 - b. Outlines the key planning and environmental considerations, for the location, siting, design and operation of renewable energy facilities and their associated infrastructure;

- c. Provides a framework that clearly stipulates the minimum required documentation and technical reports that need to be submitted with proposals for renewable energy facilities;
- d. Supports the development of Local Planning Policies by Local Governments to further guide locally appropriate planning consideration of renewable energy facilities;
- e. Provides a clear relationship with:
 - i. State Planning Policy 2.5 Rural planning and Development Control Policy 3.4 - Subdivision of rural land, to ensure planning decisions adequately balance the need to protect and preserve rural land for rural purposes;
 - ii. State Planning Policy 2.4 Planning for Basic Raw Materials to ensure proposals for renewable energy facilities consider their impact on basic raw material supply at the earliest stage of the planning process; and
 - iii. State Planning Policy 2.9 Planning for Water to ensure water resources impacted by renewable energy facilities are identified and adequately managed.
- f. Includes policy measures to address:
 - i. concerns relating to the location of these facilities and their associated infrastructure on agricultural land, their proximity to lot boundaries, town sites and sensitive land uses, and potential impact on airport operations and rural activities;
 - ii. planning for renewable energy facilities in industrial areas in relation to the coordination of these facilities, their appropriateness in the 'General Industry' zone and impacts and suitable location on heavy industry sites;
 - iii. the need for local engagement and the realisation of community benefits from the development of renewable energy facilities.
- 2. Review the definition of 'renewable energy facility' considering the increasing size and scope of facilities and consider creating definitions based on the scale of the facility (Utility-scale and other), and the form of facility (solar energy and wind energy).
- 3. Provide guidance to Local Governments on the consideration of green hydrogen production facilities on rural land where it is an incidental use to a renewable energy facility.

EXECUTIVE SUMMARY

A 2023 WALGA Annual General Meeting resolution and subsequent resolution by the Great Eastern Country Zone requested *WALGA establish and promote policies to protect and prioritise the preservation of agricultural land against its displacement by non-agricultural activities that lead to a net reduction of the State's productive agricultural land.*

The Central Country Zone resolved to request WALGA to advocate to the State Government to develop a more comprehensive and effective approach to guide the management and placement of renewable energy facilities; including but not limited to wind, solar, battery renewable diesel and associated infrastructure.

The existing State Government *Position Statement: Renewable energy facilities* does not adequately address these concerns, leading to inconsistent application and approvals of renewable energy facilities across the State.

WALGA will advocate for the existing *Position Statement: Renewable energy facilities* to be amended and elevated to a State Planning Policy, including more nuanced provisions which provide greater guidance to Local Governments and applicants, and allow for renewable energy land uses to be classified as either small or large facilities.

A joint meeting of the Environment Policy Team and Infrastructure Policy Team on 10 July endorsed the position for consideration by State Council.

This draft advocacy position should be considered in conjunction with accompanying draft WALGA advocacy positions Energy Transition Engagement and Community Benefit Frame work (Item 8.2) and Priority Agriculture (Item 8.4).

8.4 PRIORITY AGRICULTURE ADVOCACY POSITION

WALGA RECOMMENDATION

That State Council endorse a new Priority Agriculture Advocacy Position as follows:

The state planning framework should provide sufficient statutory protections for areas identified as high quality agricultural land.

WALGA calls on the State Government to:

- 1. Amend the Planning and Development (Local Planning Schemes) Regulations 2015 to:
 - a. Create a new model zone under Schedule 1, Part 3, Clause 16 for land identified as high quality agricultural land known as the 'Priority Agriculture' zone, with the following objectives:
 - i. to retain priority agricultural land for agricultural purposes; and
 - **ii.** limit the introduction of sensitive land uses which may compromise existing, future and potential agricultural production.
 - b. Define 'Priority Agriculture' zone under Schedule 2, Part 1, Clause 1 to align with the definition provided in State Planning Policy 2.5 Rural planning.
- 2. Review the areas which have been identified by the Department of Primary Industries and Regional Development as high quality agricultural land and expand the extent of mapping to address the whole of Western Australia.
- 3. Undertake a 'health check' of State Planning Policy 2.5 Rural planning and Development Control Policy 3.4 Subdivision of rural land, in consultation with relevant stakeholders.

EXECUTIVE SUMMARY

 A 2023 WALGA Annual General Meeting resolution and subsequent resolution by the Great Eastern Country Zone have requested that WALGA establish and promote policies to protect and prioritise the preservation of agricultural land against its displacement by non-agricultural activities that lead to a net reduction of the State's productive agricultural land.

- WALGA prepared a Research Paper: Protection of Productive Agricultural Land that
 provides policy context, previous WALGA advocacy and analysis of State and Local
 Government approaches to agricultural land use protections.
- This work identified that a lack of consistency between the sub-regional planning strategies across the different regions of WA has impeded the implementation of best practice planning controls into local planning frameworks, and thus inconsistent application across the State.
- This advocacy position recommends statutory protections of areas that have been identified as high quality agricultural land, through amending the *Planning and Development (Local Planning Schemes) Regulations 2015* to include a model zone for 'Priority Agriculture'. This will provide the ability for Local Governments to adopt the model zone into their local planning schemes.
- A joint meeting of the Environment Policy Team and Infrastructure Policy Team endorsed the position for consideration by State Council on 10 July 2024.
- This draft advocacy position should be considered in conjunction with accompanying draft WALGA advocacy positions Energy Transition Engagement and Community Benefit Framework (Item 8.2) and Renewable Energy Facilities (Item 8.3).

8.5 PLANNING PRINCIPLES AND REFORM ADVOCACY POSITION

WALGA RECOMMENDATION

That State Council:

- Retire Advocacy Position 6.2 Planning Reform; and
- 2. Replace Advocacy Position 6.1 Planning Principles with the following:
 - 6.1 Planning Principles and Reform
 - 1. The Local Government sector supports an efficient and effective planning system guided by legislation, policy, and processes that:
 - a. facilitates the creation of sustainable and liveable communities and places;
 - b. has a focus on strategic planning that delivers on long-term objectives and outcomes that balance social, environmental, cultural, and economic interests;
 - c. is easy to understand, accessible and transparent;
 - d. recognises the diversity of Western Australia and ensures that local environment, context, communities and character are appropriately reflected in planning frameworks and decision making;
 - e. ensures decisions are made by the level of government closest to and most impacted by a planning proposal; and
 - f. establishes consistent planning frameworks and streamlines planning processes where there is a demonstrated benefit in doing so.
 - 2. Reforms to the planning system should:
 - a. be guided by the above principles;
 - b. deliver community benefit;
 - c. promote system efficiency, including through the use of technology;

- d. be evidence-based and informed by robust, transparent data;
- e. proceed at an appropriate pace to enable effective implementation;
- f. be informed by engagement with the community; and
- g. be amended only with WALGA involvement and/or consultation/involvement with Local Government.

EXECUTIVE SUMMARY

- It is proposed that the Advocacy Positions 6.1 Planning Principles and 6.2 Planning Reform be replaced with a new contemporary combined position that reflects the current planning system and planning reform agenda.
- The updated position identifies key elements that would create an effective and efficient planning system and how planning reform can be developed, prioritised, and implemented to achieve this.
- The updated position has been informed by feedback from Local Government officers, including WALGA's Planning Advisory Group and previous WALGA submissions on State Government planning reform initiatives.
- The Environment Policy Team endorsed the advocacy position at their meeting on 29 July.

8.6 PRODUCT STEWARDSHIP POLICY STATEMENT AND ADVOCACY POSITION

WALGA RECOMMENDATION

That State Council:

- 1. Rescind the existing Extended Producer Responsibility Policy Statement and Advocacy Position 7.5 Extended Producer Responsibility.
- 2. Endorse a new Product Stewardship Advocacy Position as follows:
 - 1. Industry should take responsibility (physical and/or financial) for the waste that it generates through the entire life cycle of the products it produces through the implementation of effective product stewardship. Without effective Product Stewardship, there will be increasing costs for the community, resource recovery targets will be difficult to reach and a transition to a circular economy is unlikely.
 - 2. Effective Product Stewardship is characterised by:
 - a. Producers and importers taking responsibility for post consumption product impacts.
 - b. Schemes covering the entire cost of product recycling or recovery, including transport.
 - c. Leveraging existing Schemes and collection locations.
 - d. Being easy and convenient for the community to access.

- e. Having equitable national coverage and access for all, including regional and remote locations.
- f. Being evidence based.
- g. Consistent regulation and implementation across Australia using national Product Stewardship legislation.
- h. Timely action and industry cooperation during Scheme development and implementation.
- i. Being demand based and aiming to recover the maximum amount of material, rather than being limited by targets.
- j. No additional cost to consumers when the product is disposed of post consumption.
- 3. Local Government calls on the Commonwealth Government to implement effective Product Stewardship schemes for all products that drive environmentally and socially sustainable outcomes through the design, manufacture and distribution of products that can be more easily reused, repaired, recovered or recycled.
- 4. If national action is not progressed within a reasonable timeframe, or in a way that meets the needs of the Western Australian community, then Local Government supports a State based approach to Product Stewardship.

EXECUTIVE SUMMARY

- The <u>Extended Producer Responsibility (EPR) Policy Statement</u> was first endorsed in 2004 and reviewed and amended in 2008.
- The Statement outlines the rationale for Local Government support for EPR, as a way of
 ensuring producers take responsibility for their products at the end of life, and some of
 the key elements of successful Schemes.
- WALGA's <u>Local Government Principles for Product Stewardship</u> was endorsed in 2022.
 The Principles provided more detail on key design elements for Schemes and have been used to inform advocacy.
- Following discussion at the April Municipal Waste Advisory Council (MWAC) and Officers Advisory Group meetings it was agreed to review the EPR Policy Statement and incorporate the Local Government Principles into a new Product Stewardship Policy Statement and Advocacy Position.
- The Product Stewardship Policy Statement and Advocacy Position has been updated to:
 - o Include a greater focus on the potential for Product Stewardship to influence the design of products, as well as their post consumption disposal.
 - Identifying the increasing cost burden on Local Government and the community of increasing complex products.
 - o Focus on ensuring all products have a clear and funded end of life pathway.
- The MWAC endorsed the new Policy Statement and Advocacy Position in June.

8.7 SUBMISSION ON THE DRAFT STATE WASTE STRATEGY

EXECUTIVE SUMMARY

- The <u>Draft State Waste Strategy</u> (Draft Strategy) and <u>State Waste Infrastructure Plan</u> were released on 29 May. This follows the release of the <u>Strategy Directions Paper</u> in May 2023. WALGA provided a comprehensive <u>Submission</u> on the Directions Paper.
- Given the significant impact of the Strategy on Local Government, WALGA was granted an extension to the deadline to allow the draft submission to be considered by WALGA Zones and State Council.
- The focus of the Draft Strategy is:
 - o Better outcomes for regional and Aboriginal communities
 - o Increasing our focus on waste avoidance
 - o Better management of priority materials
 - o Realising the economic potential of recycling
 - Contingency planning and climate resilience.
- New Targets are also proposed for each of the Avoid, Recover and Protect areas.
- WALGA's draft submission on the Draft Strategy was informed by Local Government written feedback and feedback received at a webinar held on 19 July.
- This Municipal Waste Advisory Council (MWAC) endorsed the draft submission on 31 July 2024.





Heavy Vehicle Rollovers








Time Coverage Map

Ranking of Patrol Regional Districts







Configurations Intercepted

(Previous 12 months)










Offences (previous 12 months)

RoadWise Council

The RoadWise Council initiative has completed its inaugural year. Commencing in August 2023, the initiative assisted in shifting the direction of WALGA's RoadWise program to have a more proactive and focused approach to engage and support Local Governments as registered RoadWise Councils.

The initiative aims to encourage, motivate, and support Local Governments to incorporate best practice road safety principles and policy across their business services to reduce the number of people killed or seriously injured on local roads.

RoadWise Council Activity

A key element of the initiative is to capture the contribution RoadWise Councils are making towards road safety. Local Governments deliver a wide range of activities which contribute towards improving road safety performance, capturing this contribution aims to establish a base line, identify road safety priorities and progress towards best practice road safety.

WALGA's Road Safety Advisors work with Councils to identify and capture actions and align them to the RoadWise Framework. The Framework, aligned with the safe system approach, is a holistic and systematic approach, designed to guide Local Government through the important governing and management functions that will enable the delivery of better practice, and evidence-based effective road safety interventions and countermeasures.

Further, the Framework recognises the priority areas of <u>Driving Change</u> (safe roads, safe road users, safe speeds, safe vehicles, and post-crash response) and is tailored to the relevant functional areas of Local Governments. In this way, the Framework is aligned to contemporary safe systems thinking and principles and is tailored to the Local Government context.

This will help to translate best practice theory into action, it brings together the roles and responsibilities of Local Government relevant to road safety with the key elements of best practice, safe system approach.

Another part of capturing this activity is to be able to showcase and share the contribution RoadWise Councils deliver to improve their local road safety performance and support the state's road safety targets.

RoadWise Council Priorities

Registered Wheatbelt South Local Governments have identified a variety of activities to progress as part of the service, examples of these activities have been provided below.

Local Government – Road Safety Management Capacity Indicator Checklist

The purpose of this checklist is to assist Local Governments to compile and clarify their current actions, capacity and understanding of how they manage road safety outcomes on their road network. Completion of the checklist assists with establishing baseline measures, identifying priorities and working towards embedding best practice across the Local Government.

LG Stars

<u>LG Stars</u> provides Local Governments with an easy to use, cost effective method to assess the safety of the roads they manage. The tool assists RoadWise Councils road safety direction and where to apply effective, best practice road safety interventions. Completion of LG Stars provides Local Governments with a baseline safety rating for their local road network which can then be used in asset management and planning to prioritise safety upgrades.

Courtesy Speed Display Signs (CSDS)

Several Wheatbelt South Local Governments have taken advantage of or expressed interest in borrowing the CSDS. The <u>CSDS</u> allow Local Governments to:

- address elements of safe road use by encouraging behaviour maintenance or behaviour change in relation to speeding,
- support their own local area speed management treatments/works or speed limit changes by Main Roads WA to positively influence travel speeds across the network, and
- reinforce to the community their commitment to road safety, taking ownership of the road network and partnering with other to take a holistic approach.

RoadWise Council Road Safety Awards

Held on Friday 2 August, the <u>RoadWise Council Road Safety Awards</u> showcased and highlighted RoadWise Councils who are applying best practice in the planning and delivery of effective road safety interventions and the adoption of a holistic approach to road safety. In addition, the night also acknowledged those Local Governments who have demonstrated a commitment to road safety by registering as a RoadWise Council.



Road Safety Vanguards

The <u>Local Government Road Safety Vanguards program</u> provides Local Governments with practical information for reducing road trauma on the Local Government road network.

The program invites Local Government officers and Elected Members to gain knowledge of contemporary approaches to champion and influence positives in road safety.

As an introduction, participants attend a three-day workshop to hear from road safety practitioners and experts about solutions they can consider applying locally to improve road safety. The participants will then form an alumnus of "vanguards" for ongoing collaboration.

The program is a partnership between WALGA and Main Roads WA, supported by the University of Western Australia (UWA) Centre for Road Safety Research and the University of Adelaide Centre for Automotive Safety Research.
