# Central Country Zone Meeting – Friday 27 April 2018

Shire President Jeanette De Landgrafft and I attended the Central Country Zone Meeting via teleconference, at the Newdegate CRC, topics discussed during this meeting included:

- Community Resource Centre Cuts WALGA acknowledges the difficulties being faced by proposed funding cuts to CRCs and the flow on effects this may have to Local Governments and will consider previous reviews into the location and functionality of CRCs. WALGA, as a high priority, will coordinate a representative paper with affected Local Governments to highlight the long term implications for the Local Government Sector and will write to the relevant Ministers and Agencies to highlight the concerns of affected Local Governments and the need for appropriate resources and long term planning to assist rural, regional and remote communities.
- Social Media Bullying WALGA have endorsed a request to ALGA for its advocacy for changes to Commonwealth Legislation for implementing: cyber

bullying protections for all Australians, identification validation checks before a new social media account can be established and a social media / communications control order, similar to a violence restraining order, which will prevent a person from contacting any other person through social media.

### Funding for CRCs

On Monday 30 April the State Government advised that they had written to all CRCs, seeking feedback on a recommended future funding approach at a more sustainable level.

Under the recommended approach, the majority of CRCs will be offered \$70,000 per annum. Some CRCs will be offered \$50,000 per annum where they are located either:

- In a larger community a population of over 3,000 people, or
- In close proximity to another CRC or a major regional centre less than 30km.

Under this proposal, all centres will continue to receive funding from the State Government.

There is still considerable work that needs to be undertaken to ensure that our CRCs continue to receive funding and we retain the level of service we have become accustomed to.

### Anzac Day Services – Wednesday 25 April 2018

A huge thank you to everyone that was involved in the organisation and running of the Anzac Day services held across the Shire. These services are a great tribute to those who served and those lost their lives during war. Although it was a chilly morning for a dawn service, it was a great morning to watch the sunrise over Newdegate.

# Wheatbelt Development Commission – 'Meeting the Minister' Forum

On Wednesday 2 May 2018, Councilor Roz Lloyd and I attended the 'Meet the Minister" Forum, with Minister Alannah MacTiernan MLC. The mission of this forum was to discuss economic development opportunities and to learn more about the State Government's plan for the future of the Wheatbelt.

The major announcements were

• an investment of more than \$45 million in grains research and development to keep WA farmers at the forefront of the global grains market

- \$24 million of new funding for grains research and development
- Grains are worth almost \$6 billion to WA each year but face unprecedented international competition.

The \$45 million investment will be used to leverage coinvestment from the Federal Government and other sources for:

- A new cropping systems research program;
- · Genetics and crop protection projects;
- Grain product quality and market research; and
- Capacity building including university and private sector research and development grants.

### Insurance Responsibility

A friendly reminder to any Community Groups, Organisations, Associations, Social Clubs, Sporting Groups, Senior Groups etc. that undertake any activity (e.g. fund raising, holding an event etc.) should have their own insurance coverage. The insurances to consider are Public Liability, Association & Officers Liability, Volunteer Workers and Community & Family Events. The type of coverage needed depends on the activities your group undertakes.

The Shire's insurance covers any property and contents owned by the Shire and liability to the public for areas within the Shire's responsibility. If you are a group that uses Shire owned facilities or grounds to store your equipment or goods, it is important that you have your own contents insurance to cover any loss that may occur.

The Shire policy will not cover the loss of property not owned by the Shire. I am happy to catch up with any group that is concerned about the need for insurance and the limitations of our policies.

In the year 2000, Australia's insurance industry faced a public liability crisis because of the prohibitive costs for community groups. From here the Local Community Insurance Services was established to manage the special needs of clubs, community groups and not-for-profit associations. # Pension and Senior Card Rebate

# Are you a Pensioner, Senior or a Senior with WA Health Card holder?

Pensioners are eligible for 50% rebate on your rates. Seniors with a WA Health Card and Senior Card are also eligible to 50% rebate.

Those holding a Seniors Card are eligible for 25% concession. An annual maximum cap amount is applied to rates for both pensioners and seniors—this amount is reviewed each year by the State Government.

Whenever your pensioner/senior details or property ownership circumstances change, you are required to register your new entitlement.

You can do that by contacting the Water Corporation on 1300 659 951 or visiting www.watercorporation.com.au.

Concessions only apply once an application is received and registered. The Water Corporation will then forward a copy of your completed application to the Shire.

The concession will apply from the date your application is received by the Water Corporation.
