Road Construction Works

Our road construction team have just finished resheeting Fourteen Mile Rd. Re-sheeting has commenced on Parsons Rd followed by Biddy Buniche Rd and Burngup South Rd. These road projects are funded through our Federal Government Roads to Recovery funding program.

Main Roads WA have released their 2016/17 works program, in this program they have indicated that the following works will be undertaken within the Shire of Lake Grace;

- Collie Lake King Road Shoulder Grading, Pavement repairs and Crack Seal repairs, west of Newdegate
- Collie Lake King Road –Crack Seal repairs, west of Lake King
- Brookton Highway Pavement repairs, Recondition Shoulders, Crack Seal repairs, north of Lake King into the Shire of Kulin.
- Gorge Rock Lake Grace Road Shoulder Edge Break repairs, north of Kuender Road

When you enter into any of these road work sites, please ensure that you obey the regulatory signs in place. These are there for the safety of both the workers and you as a road user.

Department of Sport and Recreation Visit

Jenifer Collins, Wheatbelt Manager of the Department of Sport and Recreation will be visiting the Shire this Friday 19th August to inspect the Lake King netball courts and taking the opportunity to look at other Shire sporting facilities whilst in the Shire.

The Lake King community are proposing a court resurfacing project which will see the netball courts suitable for use as multi-purpose courts. A Department of Sport and Recreation grant through the CSRFF funding program will be sought to part fund the project and the Lake King community will be required to commit cash funds towards the project. Currently the Lake King netball courts are unplayable due to a severely cracked surface.

It is hoped the courts will be ready for the 2017 winter sports season.
