#### Workforce Survey

The results of the recent Shire of Lake Grace Workforce Survey are now on our website. There was a 20.87% response rate which is considered a reasonable return. It is obvious from the results that there is a severe shortage of workers right across the Shire within most industries.

Travel restrictions including overseas backpackers and those workers not wanting to leave the city appear to be the main concerns along with a perceived lack of suitable housing. The results of the survey have been forwarded to our local politicians including Peter Rundle MLA and Rick Wilson Federal MP. The problem regarding the lack of overseas workers and backpackers would appear to be a lost cause for farmers for the upcoming harvest however for other industries it still remains a priority in most cases.

Lack of suitable housing appears in many of the comments and is an area that should be discussed by all interested parties in the near future. The Shire of Lake Grace along with 5 other shires in our region has forwarded an Expression of Interest to the federal government for funding from the National Priority Fund 2021-2025 to fund the construction of several houses in each of the 6 shires. If approved it would go a small way in relieving some of the housing shortages however the supply of suitable housing should not just be seen as a shire responsibility.

#### **Summer Approaching**

With summer rapidly approaching it is timely to remind residents within the towns that it is time to clean up around your homes. It is noticeable around some homes that the winter rains have created havoc with the control of weeds which could rapidly develop into a fire hazard. Spring is here and it is a good time to get into the garden. A drive by inspection of all town properties will be carried out during the next few weeks. Further information regarding the requirements, both within a townsite and on rural land, accompanied your recent Shire Rates notices and is also available on the Shire website.

### **Bushfire Advisory Committee Meeting held on 16 September 2021**

With the weather starting to warm up, it is a good reminder that summer is just around the corner. Please review the 2021/2022 Fire Management Notice, particularly those on rural land to ensure your fire breaks are compliant by 1 November 2021. The Shire of Lake Grace is required to provide a safe work environment, even in the response of volunteers to suppress wildfire. Also, the Shire is required to ensure our first responders are trained in fire safety and suppression to an agreed standard for legal compliance. ### Shire of Lake Grace Tourism Advisory Committee

On Tuesday 15th September the first meeting of the Shire of Lake Grace Tourism Advisory Committee was held. Whilst three of the members were not able to make it on the day, some very interesting and valuable discussions were undertaken on the history of tourism related matters across the Shire, major 'drawcards' of our area, and marketing and promotional prospects that may prove useful ventures in the future.

The purpose of the Lake Grace Tourism Advisory Committee is to provide a mechanism by which interested persons can have an active role in advising our Council on the views, needs and interests in tourism and district promotion throughout the Lake Grace Shire. The Committee Members drawn from the community, Council and Shire staff all have experience or expertise in tourism and increasing visitation, business and other economic development opportunities. The objectives of the Committee are to advise Council on:

1. the identification, inclusion and implementation of tourism matters in Council's Strategic Community Plan and other operational plans/ annual budget in order to

increase tourism income in partnership with the Community, Commonwealth, State and Local Government and other industry stakeholders.

- 2. the co-ordination of and collaboration between Lake Grace Shire's tourist attractions, heritage facilities (AIM Hospital, Hainsworth Pioneer Centre, Varley Museum, Lake King Tractor Museum etc), events, tourism promotion/marketing and services to visitors
- 3. developing community understanding of the value of tourism
- 4. industry development, employment and training to benefit tourism, heritage and events
- 5. seeking funding to support and promote tourism and develop new and existing tourist attractions.
- 6. assisting in the development of current, quality information to visitors and stakeholders.
- 7. recognising and promoting excellence within the local tourism industry.

The next meeting of the Committee is scheduled for Monday 25th October.

Please be aware that as of 19 September 2021 the Shire of Lake Grace will enter the Restricted Burning Period, which goes until 31 October. During this period you must obtain a permit from a Fire Control Officer if you intend to light a fire. When issued with a permit to burn, you must obey all of the conditions listed on the permit. A list of Fire Control Officers is included in the recently distributed Fire Management Notice and is also available on the website.

REMINDER; For those on rural land, please ensure your mobile firefighting unit(s) are fully operational and ready to be on standby as of the 1st November as per the Shire of Lake Grace Fire Management Notice. We also recommend that these vehicles are kept maintained and in a roadworthy condition for the safety of you and your workers over the bush fire season. **Please Note:** There is no kerbside recycling collection service in Lake King or Varley.

The recycling bins are collected by Warren Blackwood Waste and transported to a recycling facility. If items which are not recyclable are found the content can't be recycled and the load will be directed to the landfill.

If an item is covered in food, it is not recyclable. Food is one of the worst contaminators in the recycling process. By using the yellow top recycling bin correctly you are contributing, in a combined community effort, to reduce the amount of rubbish that is directed to landfill facilities each year.
