#### From the CEO

Let me start off with the news in the media that the Shire of Lake Grace has been fined \$75,000 for clearing of native vegetation.

The President Cr Len Armstrong and myself attended the Albany District Court on Wednesday 19 October to hear the outcome of something that has been on the go since mid 2019.

The Shire entered a plea of guilty several months ago as there was no doubt that the offences had occurred. In pleading guilty we were hoping that the mitigating reasons behind the actions were taken into account when handing out the fine. The reasons for why permits were not applied for is not known.

#### **Media Release**

24 October 2022

Response to DWER Media statement on unauthorised clearing of native vegetation.

The fine imposed on the Shire of Lake Grace for unauthorised clearing of native vegetation dates back to the widespread storms experienced in January/ February 2017 across the southern wheatbelt which resulted in widespread flooding within the shire and an estimated \$11,700,000 of damage to local roads with the worst affected remaining under water for several months.

The fines imposed related to three existing gravel pits that had an additional area cleared totaling 4.8ha to source further gravel to aid in the reconstruction of some gravel roads that were major transport routes for farmers and also school bus routes. A further area of 1.2ha was cleared from a previously uncleared site. For some reason not known to current administration, clearing permits were not obtained.

The Shire of Lake Grace when made aware of the illegal clearing in mid 2019 took immediate steps to ensure that the correct processes were followed in the future. The Shire has been keen to bring a resolution to this matter and accepts the decision of the Court.

The total vegetation cleared across the 4 sites was 6ha from reserves totaling 29,512ha.

For clarification Cuffy's Dam referred to in DWER's comment is a Non-Potable Emergency Water Supply Dam for emergency stock water and firefighting purposes not for general use of the Newdegate community.

### **Practical Driving Assessments**

Bookings are essential for all Practical Driver Assessments.

They can be made online at <a href="www.transport.wa.gov.au">www.transport.wa.gov.au</a> or by attending the Shire Office with your Learners Permit or Current Drivers Licence.

You need to be at the office for staff to be able to book your slot, if one is available. We are unable to book the assessments for you by phone.

We are allocated 5-time slots each month and often have a very long waitlist. There is a 6-9 month wait in Perth, therefore slots are not open very long.

We understand this can be difficult but we have to abide by very strict rules as a Department of Transport Agent. We are endeavouring to ensure locals are getting slots however things are out of our control.

If you require more information on how to book your Practical Driving Assessment you can call and speak to one of our Department of Transport staff.

**Please Note:** There is no kerbside recycling collection service in Lake King or Varley.

The recycling bins are collected by Warren Blackwood Waste and transported to a recycling facility. If items which are not recyclable are found the content can't be recycled and the load will be directed to the landfill.

If an item is covered in food, it is not recyclable. Food is one of the worst contaminators in the recycling process. By using the yellow top recycling bin correctly you are contributing, in a combined community effort, to reduce the amount of rubbish that is directed to landfill facilities each year.
