### COVID-19 Case numbers

- As of **8 December 2020**, there have been **831** confirmed cases of COVID-19 notified in Western Australia (WA) and **41** historical cases. **810** people have recovered.
- To date a total of **573,766** positive and negative COVID-19 tests have been conducted in WA.

### Living with COVID

#### COVID-19 public information campaign

The key messages of maintaining physical distance wherever possible, practising good hand hygiene, staying home if sick, and getting tested, remain critical to reducing the opportunities of COVID-19 transmission in WA. The Department of Health has launched a new media campaign which aims to inform the WA community that COVID-19 is not over and remind them to practise COVID safe behaviours while enjoying summer activities.

### Community

#### Mandatory contact registers

To keep all Western Australians safe, some businesses and venues must maintain a contact register of patrons, staff, visitors and contractors for COVID-19 contact tracing, if required. The businesses affected are:

- food and licensed venues (restaurants, cafés, bars, pubs, taverns, nightclubs)
- gyms, indoor sporting centres, wellness centres, health clubs and fitness centres
- indoor play centres
- saunas and bathhouses
- swimming pool, both indoors and outdoors
- places of worship, and funeral parlours
- beauty and personal care services (hairdressers, barbers, nail salons, tattoo parlours, spa and massage parlours)
- galleries and museums
- cinemas, theatres and other entertainment venues (casino, gaming or gambling venues)
- auction houses and real estate inspections
- community facilities, libraries and halls
- zoos and amusement parks

- function centres
- hotels, motels, campgrounds or other accommodation facilities that ordinarily have check-in arrangements
- boarding schools or residential colleges (not including residents)
- adult entertainment premises (strip clubs, brothels and sex on premises venues).

Details required are location, date, name, telephone number and arrival time. Email addresses are optional.

To help businesses and venues, the WA Government has developed the SafeWA app. This is a free system that uses QR codes to register attendance. It is not mandatory to use SafeWA, but it is encouraged.

Alternative contact register formats are available, including recording details electronically or on paper. Businesses must still maintain a written contact register for people who choose not to use the SafeWA app.

## **WA's controlled interstate border**

Following updated advice from the Chief Health Officer, Premier Mark McGowan has announced that, travel from Victoria and New South Wales will be classified as 'very low risk' as of Tuesday, December 8.

Western Australia's controlled interstate border will be safely adjusted, with travel from Victoria and New South Wales to be permitted into WA with the following conditions:

- completion of a G2G Pass declaration, stipulating they do not have any COVID-19 symptoms and which jurisdictions the traveller has been in over the previous 14 days;
- all Perth Airport arrivals to undergo a health screening and temperature test on arrival;
- travellers to be prepared to take a COVID-19 test at the airport COVID clinic, if deemed necessary by a health clinician (voluntary asymptomatic testing available for all airport arrivals);
- all travellers to receive a SMS health check reminder one week into their stay in WA; and
- land arrivals to be met at the border checkpoint, for a health screening and to have their G2G Pass declaration checked.

Other jurisdictions currently in the 'very low risk' category include the Australian Capital Territory, Queensland, Northern Territory and Tasmania.

The Premier has also announced that from this Friday, December 11, South Australia will be reclassified to 'low risk' from its current medium risk classification, subject to no further community outbreaks. This means travellers from SA will be permitted to enter under the 'low risk' classification, however are required to comply with these additional conditions:

- take a COVID-19 test at the airport COVID clinic, if deemed necessary by a health clinician (voluntary asymptomatic testing available for all airport arrivals);
- self-quarantine for 14 days in a suitable approved premise; and
- present for a COVID-19 test on day 11.

The Chief Health Officer will continue to monitor and review these travel arrangements to determine if there can be any further adjustments in the future, should there be any significant changes in the public health situation.

### **Enhanced regular testing for hotel quarantine staff**

As part of the new weekly mandatory testing program, security personnel and cleaning staff at all State-run quarantine hotels will be tested every 7 days. The new testing program better protects hotel quarantine workers and adds to the protection measures already applied at WA's State-run hotel quarantine system.

## **Testing**

### **General population [testing criteria](#)**

Any person may be tested if they have any one of the following clinical criteria: fever ( $\geq 37.5^{\circ}\text{C}$ ) OR history of fever (e.g. night sweats, chills), without a known source **OR** an acute respiratory infection (e.g. shortness of breath, cough, sore throat, runny nose) **OR** acute loss of smell or taste.
